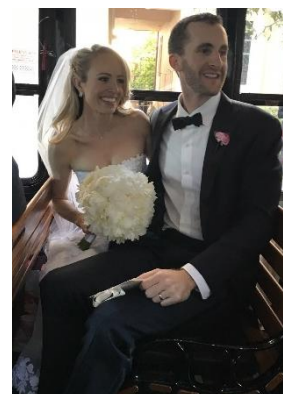
Thanksgiving 2017
